Transitional arrangements for qualification 98690 (LLB) for 2020

Modules passed in the old curriculum	Equivalent modules that may not be taken in the new curriculum	Modules exempted in the new curriculum	Comments
SCL1502 ENN106J	IRM1501	IRM1501	A student who has passed SCL1502 or ENN106J shall be exempted from doing IRM1501.
FLS1501 & FLS1502	HFL1501	HFL1501 and PLS1502	A student who has passed FLS1501 AND FLS1502 shall be exempted from HFL1501 and PLS1502. A student who has passed FLS1501 OR FLS1502 shall be required to register for HFL1501, but do not have to register for PLS1502.
CIP2601 & CIP3701	CIV3701	CIV3701	A student who has passed CIP2601 AND CIP3701 shall be exempted from registering for CIV3701
CMP2601 & CMP3701	CPR3701	CPR3701	A student who has passed CMP2601 AND CMP3701 shall be exempted from registering for CPR3701
EVI3701 & EVI3702	LEV3701	LEV3701	A student who has passed EVI3701 AND EVI3702 shall be exempted from registering for LEV3701.
HMLLB80	RRLB81	LME3701	Students who have passed HMLLB80 are not allowed to register for RRLB81 but are required to take another elective on the 4 th year level if needed to meet the 480 credit requirement for the degree and/or the 120 credits required on exit level (NQF level 8). A student who has passed HMLLB80 shall be exempted from doing LME3701.
MRL4801	LML4806		A student who has passed MRL4801 shall be exempted from doing LML4806.
EUP1501	SJD1501		A student who has passed EUP1501 shall be exempted from doing SJD1501.
CRW101U	SJD1501		A student who has passed CRW101U shall be exempted from doing SJD1501.

ILW1014 & ILW1025 & IND101S & IND102T	FAC1503		A student who passed 2 ILW and 2 IND modules shall be exempted from doing FAC1503
Two language modules	SCL1501 & IRM1501		A student who passed two language modules shall be exempted from doing SCL1501 & IRM1501

Important notes:

- TLI4801 is no longer exempted since it is a compulsory module.
- CIV/LEV/CPR may not be substituted. In some instances, students will have more than 40 modules on their records due to these compulsory procedural modules.
- Old procedural modules CMP/CIP/EVI collapsed into 1 module respectively. Outstanding new modules on first to third levels can be replaced by extra old modules respectively (according to the substitution table provided by the academics), however, 1st, 2nd and 3rd level modules may never replace modules on 4th level.
